## 1. SECURITY MEASURES

The Responsible is committed in having the technological, material and human infrastructure that ensures that your personal data is treated in a responsible, lawful, fast, accurate, complete and secure manner. Also, it will keep your information only for as long as is appropriate for the purposes mentioned in this notice or as required by applicable law.

## 2. PERSONAL DATA COLLECTED

The personal data that the Responsible will collect includes all those that are captured by the recording system, such as images and sounds of the people who enter and transit through the facilities of Punta Mita Development, which is a biometric type of personal data that makes them identifiable.

## 3. PURPOSE

In accordance with the Federal Law on Protection of Personal Data Held by Private Parties, its Regulations and the Privacy Notice Guidelines; these personal data is carried out for the following purposes: 1. Provide security and vigilance to the activities carried out within the Punta Mita Development; 2. Traffic control of people; 3. Protect the assets and people that are within its facilities; 4. Be offered and reproduced in any type of judicial and / or extrajudicial act or diligence; 5. Prevent and/or report the commission of crimes, illicit or irregularities; 6. Prevent any act of corruption, and 7. Those that are similar or analogous to the previous ones.
